

PRIVACY POLICY

Website Privacy Policy of Vienna Youth Soccer, Inc.

Vienna Youth Soccer values the support of our members, donors, board members, and others who support Vienna Youth Soccer (VYS) through visiting our website. We know that protecting personal information is important to our readers.

Before you submit any information on this site, please read this Policy for an explanation of how we will treat your personal information. By using this Demosphere site you consent to the collection and use of your personal information as outlined in this Policy.

Your use of any part of this site indicates your acceptance of this Policy and of the collection and use of your personal information in accordance with this Policy.

Type of Information We Collect - When you register your child for programs on-line and at other times, we will be collecting personally and non-personally identifiable information from you about your family and your child.

The personally identifiable information we collect may include personal information about you, such as your name, address, telephone number, e-mail address and credit card number, as well as personal information about your child, such as his or her name, address, school, grade level, birth date, and gender.

We only request information that is required to ensure that your child can effectively join and participate in our programs, and do not condition your child's participation in our programs on the disclosure of more information than is reasonably necessary.

We also may collect certain non-personally identifiable information when you visit many of our web pages such as the type of browser you are using (e.g., Netscape, Internet Explorer), the type of operating system you are using, (e.g., Windows 98, Windows 2000 or Mac OS) and the domain name of your Internet service provider.

Children – VYS respects the privacy of children and does not collect any more information than what is deemed necessary to participate in our programs.

No information should be submitted over this website by visitors under 18 without the consent of their parent or guardian. We encourage young people to check with their parents before entering information on any website.

Parents and guardians have the right to consent to the collection and use of their child's personal information without consenting to the disclosure of that information to third parties. Photos of children will only be posted once given consent from his/her parent or guardian.

Cookies - VYS does not use cookies on our website.

How We Use Information Collected – VYS and Demosphere International (3rd party website vendor) may use and disclose the personal information you provide about your family to enable us to process, validate and verify your request to register your child in VYS programs and to operate VYS's operation.

If you visit our site to read or download information, we may collect and store website usage information. This non-personal information enables us to analyze trends, gather broad demographic information, and monitor site traffic patterns that can help us further develop and improve the design and functionality of our site.

We may also share such information with governmental authorities when legally required to do so or at the request of a governmental authority investigating a crime. We reserve the right to contact you regarding on-line registration related problems or questions as well as to provide you with information regarding changes to our terms and conditions, to our Privacy Policy, or to other policies that affect you and your use of the website.

Opting Out - We will not share your email address with other organizations. If you receive an e-mail from us, you may choose not to receive such messages in the future by following the "unsubscribe" link which we put in the footer at the bottom of each e-mail.

Use of Photographs and Player Identification - By submitting articles and photographs for website posting and/or media distribution, team representatives and individual members authorize VYS on behalf of all named and pictured parties to in fact publish these items.

Security Measures - We rely on Demosphere to have put in place appropriate physical, electronic, and managerial procedures to safeguard and help prevent unauthorized access, maintain data security, and correctly use the information we collect online.

Links to affiliate or third party websites - We may make content from affiliated websites or other third party websites available to you from links located on this website. These websites are not subject to this Privacy Policy. We recommend that you review the privacy policy at each such website to determine how that website protects your family's privacy.

Policy Modifications - We may change this Privacy Policy from time to time. We will post any changes here, so be sure to check back periodically. However, please be assured that if the Privacy Policy changes in the future in any material respect, we will not use the personal information you have submitted to us in a manner that is inconsistent with this Privacy Policy, without your prior affirmative consent.
